# **Study After Law School**

The postgraduate programs offered at the Adelaide Law School enable students to further develop legal skills across a broad range of interests.

## Why study as a postgraduate?

- Specialise in areas of commercial law, or wish to improve their scholarly skills
- Improve employability
- Develop knowledge in a parcular area of interest
- Career path where postgraduate study is a requirement.
- Work alongside leading experts and legal minds

Postgraduate study is conceptualised into two streams: High Degree By Research and Coursework.

#### **Coursework programs**

#### Master of Laws: 24 Units over 1 year Full Time

#### **Program Requirements**

There are four different entry pathways. Students must have either completed:

- 1. A Honours degree of Bachelor of Laws; or
- 2. A Bachelor of Laws and the GDLP; or

- 3. A Bachelor of Laws and substantial profession experience within the profession (this is considered to be at least two years of practice as either a barrister or a solicitor); or
- 4. A Bachelor of Laws and substantial research experience within the profession (this is the ability to demonstrate knowledge of underlying legal principles at an advanced level)



#### **Program Highlights**

- Students focus their program through a broad range of elective options
- Advance legal writing, reasoning and analytical skills
- Study with legal professionals, judges and international academics
- Complete a substantial research piece of scholarsip

#### Master of Comparative Law: 30 Units 15 months

#### **Program Requirements**

At least a credit average in your Bachelor of Laws undergraduate degree

#### **Program Highlights**

- Joint program at the Adelaide Law School and the prestigious University of Mannheim Law School in Germany.
- First semester in Adelaide, the second in Mannheim and the third in Adelaide during which students complete a dissertation
- Entire program conducted in English
- Explore different legal

systems and examine diversity in order to understand, improve and reconcile differences

• Study the different systems of law across the globe, including common, civil and even Islamic law

Master of Philosopy (MPhil): 2 years (maximum)

#### **Program Requirements**

A University of Adelaide Bachelor degree with a minimum of a distinction average (6.0 GPA)

#### Doctor of Philosopy (PhD): 2 years (maximum)

#### **Program Requirements**

You	will	need	one
of	the	following:	

- 1. A relevant University of Adelaide Honours degree with at least a second-class Honours; or
- 2. A postgraduate coursework degree which contains a significant research component and meets the minimum GPA requirements; or
- 3. A relevant University of Adelaide Research Master (or equivalent)
