

If elected, my term would represent my values of promoting diversity and inclusion and would seek to better support AULSS members through initiatives including:


- -Work with faculty to better support students arising from marginalised community.

I have enjoyed working on the AULSS and I would love to continue giving back to this community if elected.





The benches in the Ligertwood foyer have a Hilarian-shaped hole in their hearts. Bring their baby home. Vote for us. What's the worst that could happen?


SOCIAL JUSTICE & EQUITY REPRESENTATIVES


